## INVITATION TO SUBMIT AN EXPRESSION OF INTEREST FOR THE CONCESSION OF THE CRUISE ACTIVITY

- (A) IN THE PORT OF KATAKOLON AND IN A SECTION OF THE OLD PORT OF PATRAS (LOT 1)

  AND
- (B) IN A SECTION OF THE CENTRAL PORT OF KAVALA "APOSTOLOS PAVLOS" (LOT 2)

On 31.12.2024, the Merger Agreement dated 23.12.2024 (Government Gazette B 7093/24.12.2024) was registered in the General Commercial Register (G.E.M.I.) with Registration Code 5215680 providing for the absorption of the company under the corporate name "Hellenic Republic Asset Development Fund S.A." ("HRADF") and G.E.MI. no. 117034801000 by the company under the corporate name "Hellenic Corporation of Assets and Participations S.A." ("HCAP") and G.E.MI. no. 140358160000, pursuant to articles 188A and 188B of Law 4389/2016, as added by articles 5 and 6 of Law 5131/2024 (Government Gazette A 128/02.08.2024), and the provisions of Law 4601/2019, as in force.

Following the above and in accordance with Article 34 para. 8 of Law 5131/2024, the Tender Procedure for the concession of the cruise activity (a) in the Port of Katakolon and in a section of the Old Port of Patras (Lot 1) and (b) in a section of the Central Port of Kavala "Apostolos Pavlos" (Lot 2), which was launched by virtue of the Invitation for the Expression of Interest of 23.12.2024 issued by HRADF (the "Invitation"), is continued by HCAP, as HRADF's universal successor, in accordance with the terms of the Invitation and the applicable legislation. From 31.12.2024 onwards, all references in the Invitation to HRADF shall be construed as references to HCAP.

Further, HCAP announces hereby its decision to extend the Submission Deadline specified in Section 5.2 of the Invitation in respect of the submission of an Expression of Interest until the **31st of March 2025 and until 17:00 (Greek time, UTC +2)**.

It is clarified that any Supporting Documents issued within the deadline of 30 days before the initial Submission Date, namely from 29 January 2025, will be accepted by HCAP. In such case, the following phrase should be added in the sworn statement / solemn declaration of Statement Template 2 of Annex B of the Invitation:

"All information, statements, declarations, Supporting Documents and other accompanying documents we have submitted together with our Expression of Interest are true, in force, valid and accurate and there has been no change since their issuance date and we have not concealed any information related to such

<u>information, statements, declarations, Supporting Documents and other accompanying documents</u>, the Tender Process and the Transactions".

Furthermore, it is noted that the deadline for submission of clarification requests by the Interested Parties in accordance with paragraph 5.4 of the Invitation will be extended accordingly, namely until the **16**<sup>th</sup> **of March 2025 and until 17:00 (Greek time, UTC +2)**.
