We would require assistance on ensuring the smooth execution of the Hand Over and signoff on the completion. 5	The maximum duration of the project is eighteen months. What are the envisaged tasks for the Expert following the appointment of a new concessionaire on 01 May 2026?	The maximum duration of the project is eighteen months, or the completion of the Transaction, whichever occurs first.
6	Can the Growthfund please share the Existing Concession Agreement (as referred to in the Scope of Work)? This will help with better understanding the work task. The financial information regarding the Existing Concessionaire, being a private limited company, is available in the company's financial statements. All the required relevant information shall be uploaded on the VDR to be set up for the transaction.
