Unfolding the Tender Process

Overview

The Hellenic Corporation of Assets and Participations S.A. ("GROWTHFUND") and its Advisors (Financial, Legal, and Technical) are preparing the process for an International Tender for the <u>sub-concession of cruise activities in sections of the central port of Kavala and the old port of Patras, as well as the concession of the Port of Katakolon (Municipal Port Fund of Pyrgos), aiming to develop cruise services in these ports.</u>

- By virtue of Article, para 2 of Law 4597/2019, HRADF* was transferred the right to sub-concede to third parties specific port functions and services of port facilities, within the jurisdiction area, *inter alia*, of the Port Authorities of Kavala and Patras S.A.
- By virtue of the Decision No 218 of the Interministerial Committee for Restructuring and Privatizations (G.G. B' 2322/13.08.2012), HRADF was transferred the right to grant concessions to third parties, through concession agreements, of any rights of use, administration, management, and exploitation of movable and immovable property within the land and/or sea zones, including, *inter alia*, the Port of Katakolon.

TWO INVESTING OPTIONS

The Tender is divided into **two (2) lots.**Interested parties may submit their expression of interest for one or both lots of the Tender.

Lot 1

- Concession Agreement for the Port of Katakolon: An agreement for the concession of the right to use, maintain, operate, and exploit the (entire) Port of Katakolon, with cruise activity being the primary focus. The concession duration will be at least 30 years. The concession agreement will be signed between the GROWTHFUND and the Preferred Investor selected for Lot 1 of the Tender and cosigned by the Hellenic Republic.
- <u>Sub-Concession Agreement</u> for the cruise activity at the northern (old) Port of Patras: An agreement for the sub-concession of the right to use, maintain, operate, and exploit a section of the northern (old) Port of Patras exclusively for cruise activity. The duration of the sub-concession agreement will be at least 30 years. The sub-concession agreement will be signed between the Hellenic Republic, the GROWTHFUND, Port Authority of Patras S.A., and the Preferred Investor selected for Lot 1 of the Tender.

Lot 2

<u>Sub-Concession Agreement</u> for the cruise activity at the Central Port of Kavala: An agreement for the sub-concession of the right to use, maintain, operate, and exploit a section of the (passenger) central port of Kavala 'Apostolos Pavlos' exclusively for cruise activity. The duration of the sub-concession agreement will be at least 30 years. The sub-concession agreement will be signed between the Hellenic Republic, GROWTHFUND, Port Authority of Kavala S.A., and the Preferred Investor for Lot 2 of the Tender.

CENTRAL PORT OF KAVALA

The Kavala Port Authority S.A. was granted the exclusive right to use and exploit the land plots, buildings, and facilities within the port land zone of the Central Port of Kavala, under a Concession Agreement with the Hellenic Republic as ratified by Law 4597/2019. According to Article 33 of Law 5058/2023 the duration of the concession has been set at sixty-five (65) years from the date of its signing, expiring on January 15, 2068.

OLD PORT OF PATRAS

The Patras Port Authority S.A. was granted the exclusive right to use and exploit the land plots, buildings, and facilities within the port land zone of the Port of Patras, including the old port of Patras, under a Concession Agreement with the Hellenic Republic as ratified by Law 4597/2019). According to Law 4664/2020, the duration of the concession has been set at sixty (60) years from the date of its signing, expiring on December 12, 2062.

PORT OF KATAKOLON

The legal entity of public law under the name 'Municipal Port Fund of Pyrgos' (M.P.F. of Pyrgos) exercises the responsibilities of the Katakolon Port Fund that pertained to the Municipality of Pyrgos and were transferred to the Municipality under Presidential Decree 159/2001.

Port of Katakolon: Key Asset Information

The **Port of Katakolon** serves as a vital economic hub for the region, attracting tourists and creating employment **opportunities for the local community.** The port serves as the port of the city of Pyrgos. The Port of Katakolon functions as a key port of call for cruise ships mainly due to its geographical location and the nearby attractions of Ancient Olympia; it features three dedicated berths for cruise vessels, while servicing some small general cargo vessels, tankers, as well as leisure and fishing boats. The port can accommodate third-generation cruise vessels over 350 meters in length. The maximum depth at the cruise berths is approximately 9 meters. According to the current masterplan, a new pier with two additional cruise berths is foreseen. The port operates in compliance with the International Ship and Port Facility Security Code (ISPS), ensuring robust safety and security measures for both passengers and vessels.

Ancient Olympia

Ancient Olympia, an impressive **UNESCO World Heritage Site**, is home to remarkable archaeological treasures, including the ruins of the **Temple of Zeus**, just **over a 30-minute drive from the Port of Katakolon** (~33km).

Ancient Olympia, famously recognized as the **birthplace of the Olympic Games**, hosted the prestigious ancient competitions from 776 BCE to 4 AD.

Sandy Escapes

Explore the beautiful beaches near Katakolon, with crystal waters and golden sand.

Kourouta beach; a famous destination with beachfront taverns, only 30-minutes away from the port.

Skafidia beach; beautiful crystal-clear waters and only 20-minutes away from the port.

Kaiafas beach; visit the huge sandy beach next to Kaiafas lake, just 40-minutes away from the port.

Nemouta Waterfalls

The Nemouta Waterfalls are located around Erymanthos River, only a **70-minute drive from the port of Katakolon**.

The Nemouta waterfalls include a series of thirty waterfalls one can view following a hike through the beautiful forest.

The **designated Port Land Zone includes (a)** the **cruise port area** on the south of the port, as well as **(b)** a small **basin** for use by small fishing boats and leisure boats located on the north side of the port basin. Apart from the main cruise area, the small basin on the north side of the port will be part of the concession.





Old (Northern) Port of Patras



Old (Northern) Port of Patras: Key Asset Information

The **old (Northern) Port of Patras** covers a total area of approximately 577,050 square meters, extending along a zone of approximately 6,500 meters in length. The Port of Patras is classified as a **port of international interest** and is part of the core network of the **Trans-European Transport Networks** (TEN-T). Its total quay length is 2,000 meters, and within its area, there are administrative/technical service buildings, warehouses, sheds, shops, and refreshment areas. The new (Southern) Port of Patras occupies an additional area of 255,000 square meters and serves as the hub for international ferry passengers traveling to/from Adriatic ports, with connections also to the ports of Pendik and Yalova in Turkey. **Based on the latest masterplan, berth No.** 14 of the <u>old port is designated for exclusive use by cruise ships.</u>

Nafpaktos

The beautiful town of Nafpaktos, located next to the sea, is only a **35-minute drive from the port**.

Ancient Korinthos; a Greek, Hellenistic, and Roman city dating back between 5000 to 3000 BC.


Archaeological Site of Delfi; magnificent monumental complex, part of UNESCO world heritage and home of Pythia, the Oracle of Apollo.



Old (Northern) Port of Patras: Upward Trends in Cruise Calls



Central (Passenger) Port of Kavala: Key Asset Information

The Central Port of Kavala consists of the Passenger Port "Apostolos Pavlos" serving passenger traffic (ferry and cruise), and the Fish Market; a section of the Central Port of Kavala along with the use of existing building will be sub – conceded for the development of cruise activities. The Port Authority of Kavala S.A. manages the Central Port of Kavala along with (not included in the transaction perimeter): (a) The Commercial Port of Kavala "Philippos II", which handles commercial cargo traffic (soon under concession to a private investor); (b) The Port of Keramoti, which facilitates the transportation of goods and passengers to/from the island of Thasos; (c) The Port of Eleftheres, which accommodates leisure boats and some bulk cargo transportation.

The sub-concession for cruise operations will include one large berth of 470 m and a land area of ~1.5 ha.

Located **16km from the port,** the city is connected with important events during the Roman years.




The Waterway Trail

Located **2km away from the port**, the Waterway Trail **connects the village of Palaia Kavala to the city center**, following the path of an ancient aqueduct.

Lush forests, diverse vegetation, and panoramic views create a scenic journey, while the trail highlights the area's rich engineering heritage and natural beauty.

The land area for the sub-concession includes (a) the area behind the 470 m, (b) a land area of ~1.5 ha as well as (c) an existing building inside the land area of the Central Port of Kavala to be refurbished and used by the sub-concessionaire. A new masterplan is currently being prepared and is expected to be finalized soon.


