1. Following a resolution of its Board of Directors, dated 14.04.2022, the Hellenic Republic Asset Development Fund (the "Fund") has decided to amend the Invitation for the Submission of Expressions of Interest for the Sub-concession of the Right to construct, operate, manage, maintain and exploit of the Corfu MegaYacht Marina, dated 17.02.2022, (the "EOI") as follows:

In paragraph 4.2.4 of the <u>Greek version</u> of the EOI the phrase "At least 3 berths for super yachts larger than 70 m.» is deleted. Subsequently, paragraph 4.2.4 of the Greek version is reads as follows:

"The technical capacity requested is to demonstrate experience with the development and operation of at least one (1) marina, with at least 3 years of continuous operation in the last five (5) years, with the following (or larger) capacity and characteristics:

- a capacity of more than 150 berths
- at least 50 berths for yachts larger than 25 m
- commercial real estate included in the marina project, with a constructed area of at least 5,000 m2"
- 2. The English version remains as it is.
- 3. The remaining provisions of the EoI remain unchanged.
- **4.** In other respects, the provisions of the EOI apply.
