Please confirm that in case the Candidate is an association or consortium of companies, the above-mentioned minimum budget can be met cumulatively by all the consortium members i.e. by multiple projects implemented by the consortium members. In par. 3 of section "Dossier A' Part 1: Track Record and Experience" of art. 4 of the above RfP, it is stated that "the Head of an association or consortium of domestic and/or foreign companies must have proven experience and participation over the last five years in complex ongoing and/or implemented development projects and large-scale infrastructure projects with a minimum budget of €200,000,000". In accordance with question no.1 above, please clarify whether the aforementioned minimum budget can be met cumulatively by multiple projects in which the Head of the association or consortium has participated. With regards to the minimum required qualifications requested in the above RfP and, more specifically, the Track Record and Experience as well as the financial capacity requested, we would like to clarify the following: In case that a Candidate or a member of an association or a consortium is a Group Member Company (100% subsidiary of the parent company), can it make use of aggregate references and consolidated financial data of the Group through a letter of undertaking signed by the CEO of the Group Holding (parent company)?	No it cannot. The minimum required qualifications requested in the above RfP should be met by the candidate company itself, or by the member company itself, in case of an association or consortium of companies.
