On the questions submitted until 21.01.2022 regarding the Request for Proposal dated the 14th of January of 2022 for the provision of services of an Implementation Advisor responsible for monitoring the execution of the Integrated Development Plan of the Metropolitan Pole of Ellinikon – Agios Kosmas ("the RfP"), HRADF provides the clarifications contained within this document.

In par. 4 of section "Dossier A' Part 1: Track Record and Experience" of the above RfP, there is a reference with regards to the minimum requirements in relation to the financial adequacy of each Candidate. Specifically, it notes that in case of an association or consortium, "each member must demonstrate a minimum annual turnover of at least two million euros (€2,000,000) over the last three years." Could you please clarify whether the aforementioned minimum requirement of financial adequacy can be met cumulatively by a group of law firms, if for example, they decide to join an association or consortium of companies in order to participate in the Tender and provide legal services for the Project?	As explicitly noted in the RfP in case the Candidate is an association or consortium of foreign and/or domestic companies, each member of such association or consortium must demonstrate a minimum annual turnover of at least two million euros (€2,000,000) over the last three years. This requirement may not be met cumulatively by a group of law firms, which may potentially join an association or consortium in order to participate in this RfP and thus provide legal services for the Project. As such, it is helpful to clarify even further that the above term of the RfP applies to each type of company, member of a potential Candidate association or consortium of foreign and/or domestic companies, regardless of the type
			of services provided (technical, financial, legal) for the execution of the Project.
