- 1. The Hellenic Republic Asset Development Fund S.A. (the "Fund") by virtue of a decision dated 21.12.2017 of its Board of Directors has approved the amendment of the Invitation to submit an Expression of Interest for the award of service concession agreement in relation to financing, operation, maintenance and exploitation of Egnatia Odos and three vertical road axes dated 14.11.2017 (the "Invitation") as follows:
 - (i) In the 1st, 2nd, 3rd and 4th sentences of paragraph 8.6 of the Invitation references to an "Affiliate" deleted and replaced by references to a "third party" respectively and, consequently, paragraph 8.6, following its amendment as per the aforementioned, applies as follows: "An Interested Party or a Consortium member may rely on the financial eligibility of a third party. In such case, the Interested Party or Consortium member must demonstrate that the respective third party shall provide it with all the financial resources necessary for the completion of the Transaction and for the financing, operation, maintenance and exploitation of the Road Axis. The inclusion in the Expression of Interest of a solemn declaration pursuant to Law 1599/1986, signed by the legal representative of the third party, declaring that the third party undertakes to make available to the Interested Party (or in the case of a Consortium, a member thereof) all necessary financial resources and that it will be responsible towards the Fund where the conditions set out in this paragraph are not met (Annex C - Template 1), shall be deemed in all events to be adequate means of proof. Moreover, the aforementioned third party must fulfill the provisions of paragraph 5.10 and meet the Personal Situation Criteria of Article 7, whereas all documents specified in paragraphs 10.5 and 10.6 hereof, should be also submitted regarding such third party".
 - (ii) In paragraph 7.7 of the Invitation the words "Affiliate or", where found, are deleted and, consequently, paragraph 7.7, following its amendment as per the aforementioned, applies as follows: "Where the Interested Party (or Consortium member) relies on the financial standing or the technical capacity of a third party to meet the Financial Eligibility or Technical Eligibility Criterion respectively, in accordance with paragraphs 8.6 and 9.4 below, the Personal Situation Criteria as defined above must also be met by said third party".
 - (iii) In paragraph 10.6 (i) of the Invitation the word "Affiliate", where found, is replaced by the words "third party" and, consequently, paragraph 10.6 (i), following its amendment as per the aforementioned, applies as follows: "Each Interested Party must submit in Section III of the Expression of Interest copies of published, audited consolidated financial statements of the last three (3) financial years, and, to the extent that the Interested Party relies on the financial resources of a third party, copies of the published, audited consolidated financial statements of the last three (3) financial years for the said third party. Where publication of financial statements is not required under the law, the Interested Party must also submit along with the documents required by the Invitation, unpublished financial statements, a solemn declaration pursuant to Law 1599/1986 confirming that such publication is not required (Annex F Template 1)".
 - (iv) Template 1 of Annex C of the Invitation is replaced as follows:
