This would not be possible. Per clauses 5.3.4 and 5.4.2, such Solemn Declarations should be provided in the form and the <b>content</b> of the sample declarations attached to the Invitations as Annexes III and IV respectively. Moreover, as also noted above under question 3, the Solemn Declarations forming part of an Interested Party's Expression of Interest may not be subject to any conditions.
