1.	12.1, 10.2 (viii), 10.5 (i)	<u>Clarification provided with the Fund’s initiative</u>	Following the Fund’s Board of Directors decision dated 18.1.2018 the Submission Date of the Expressions of Interest (as defined in clause 11.1 of the Invitation) was amended and set for the 16th February 2018. Therefore any reference in the Invitation to the Submission Date should henceforth be read as a reference to the aforementioned date. In view of that the Fund draws the attention of any Interested Parties, indicatively, to the following: (i) The deadline for the submission of requests for clarifications (as provided under clause 12.1 of the Invitation) is accordingly extended until the 1st of February 2018 until 17.00 (Greek time, GMT + 2), i.e. 15 days prior to the new Submission Date; (ii) according to clause 10.2 (viii) of the Invitation, all Supporting Documents must have been issued and (where required) certified within the last 90 days prior to the new Submission Date i.e. prior to 16th February 2018; (iii) the certificate from a commercial registry or other equivalent
