



EXTENSION OF SUBMISSION DEADLINE

**INVITATION TO SUBMIT AN EXPRESSION OF INTEREST FOR THE ACQUISITION OF A
MAJORITY STAKE IN THE SHARE CAPITAL OF THE COMPANY UNDER THE
CORPORATE NAME «HELLENIC SALTWORKS S.A»**

Athens, 23 January 2026

In connection with the Invitation to Submit an Expression of Interest for the acquisition of a majority stake in the share capital of the company under the corporate name «HELLENIC SALTWORKS S.A», issued by the company «HELLENIC CORPORATION OF ASSETS AND PARTICIPATIONS» (the «**Growthfund**») on 15.12.2025 (the «**Invitation**»), the Growthfund announces its decision to extend the Submission Date specified in Section 5.2 of the Invitation in respect of the submission of an Expression of Interest until the **2nd March 2026 at 15:00** (Greek time, GMT +2).

It is further noted that the deadline for the submission of clarification requests by the Interested Parties, in accordance with Section 5.4 of the Invitation, is correspondingly extended so as to fall fourteen (14) full calendar days prior to the new Submission Date set out herein, and until 17:00 (Greek time, GMT +2).

It is clarified that any Supporting Documents issued within the deadline of thirty (30) calendar days prior to the initial Submission Date, namely from 31th December 2025 onwards, will be accepted by the Growthfund. In such case, the following phrase should be added in the sworn statement / solemn declaration of Statement Template 2 of Annex B of the Invitation:

“All information, statements, declarations, Supporting Documents and other accompanying documents we have submitted together with our Expression of Interest are true, in force, valid and accurate and there has been no change since their issuance date and we have not concealed any information related to such information, statements, declarations, Supporting Documents and other accompanying documents, the Tender Process and the Transaction”.
